# CITY OF SANTEE

(This Measure will appear on the ballot in the following form.)

## MEASURE Q

"Shall the measure amending the Santee Municipal Code to require that no person shall serve as an "Elected Official," defined to include the offices of Mayor and Member of the City Council, for more than twelve years, or three terms, whichever is less, with any portion of term, whether by election or appointment, counting as a full term, be adopted?"

This measure requires approval of a simple majority (50% plus 1) of those voting on the measure.

Full text of this measure follows the arguments and Rebuttals.

#### CITY ATTORNEY IMPARTIAL ANALYSIS

The City of Santee currently does not have term limits for its Mayor or City Council.

Measure "Q" would amend the Santee Municipal Code to provide that no person shall serve as an "elected official" for more than twelve years, or three four-year terms, with any portion of a term, whether by election or appointment, counting as a full term. The Measure defines "elected official" to include the offices of the Mayor and Member of the City Council. Therefore, if Measure "Q" is approved, no person could serve as either Mayor or City Council Member, or in any combination of those positions, for more than a total of twelve years, or three four-year terms, with any portion of a term counting as a full term.

Measure "Q" was placed on the ballot by a petition signed by the requisite number of voters.

If Measure "Q" is approved, pursuant to the Elections Code, and notwithstanding any contrary language in the Measure, the term limits would apply only to future terms, elected or appointed, beginning with the terms that commence as a result of the November 3, 2020 election.

A separate term limits measure, Measure "R," is also on the ballot. Under the Elections Code, if both Measure "Q" and Measure "R" pass with a majority of "yes" votes, the measure receiving the highest number of "yes" votes will become the operative law of the City, and can thereafter be amended or repealed only by a majority of the voters at a subsequent City election.

## ARGUMENT AGAINST MEASURE Q

The Santee Term Limits Committee requests you vote NO on measure Q.

#### FULL TEXT OF MEASURE Q

#### THE SANTEE TERM LIMITS INITIATIVE

To the honorable Clerk of the City of Santee: We, the undersigned, registered and qualified voters of the City of Santee, hereby propose an initiative measure to establish Term Limits for elected officials. We petition you to submit this measure to the City Council for the City of Santee for adoption without change, or for submission of the measure to the voters of the City of Santee at the earliest regular or special election for which it qualifies. The measure provides as follows:

#### THE SANTEE TERM LIMITS INITIATIVE

#### **SECTION 1: PURPOSE, EFFECT AND FINDINGS**

**WHEREAS**, the elected officials of the City of Santee currently are Mayor and members of the City Council; and,

WHEREAS, the City of Santee currently does not have term limits for City elected officials; and,

#### WHEREAS, term limits for City elected officials will:

- Avoid potential abuses of power by elected officials who stay in office too long
- Encourage new people to get involved in local government
- Broaden the base of potential candidates
- Increase responsiveness to the public
- Encourage fresh ideas
- Provide voters with more choices
- Increase voter turnout
- Ensure a healthy balance of power among different interest groups
- Encourage more diversity among City Council members
- Encourage broader representation of different neighborhoods; and,

**WHEREAS**, it is in the best interests of the City that term limits be established for all elected offices in the City, and it is the purpose and intent of this Ordinance to achieve the positive impacts of term limits mentioned above.

#### SECTION 2: AMENDMENT OF THE CITY OF SANTEE MUNICIPAL CODE

# NOW, THEREFORE, THE PEOPLE OF THE CITY OF SANTEE, CALIFORNIA, DO ORDAIN AS FOLLOWS:

Title 2 Administration And Personnel. Chapter 2.08 City Council, a new Section '2.08.030 Term Limits For Mayor And City Council' is added to Title 2 of the Santee Municipal Code to read, in its entirety, as follows:

#### 2.08.030 TERM LIMITS FOR MAYOR AND CITY COUNCIL

Section 2.08.03010. Elected Official

## **FULL TEXT OF MEASURE Q (CONTINUED)**

The term 'elected official' as used in this Chapter includes the offices of:

- A. Mayor, and
- B. Member of the City Council.

#### Section 2.08.03020. Partial Terms of Office.

Any portion of a term, whether by election or appointment, shall count as a full term.

#### Section 2.08.03030, Term Limits.

The Santee Term Limits Initiative requires that no person shall serve as an elected official more than twelve years, or three four-year terms as a member of the Santee City Council, with any portion of a term, whether by election or appointment, counting as a full term.

### Section 2.08.03040. Application.

The term limits described in this Chapter shall apply to terms of office beginning on or after the general election held on November 6, 2018.

## **SECTION 3: IMPLEMENTATION**

- **A. Effective Date.** The effective date means the date that the Santee Term Limits Initiative becomes effective pursuant to State law.
- B. Severability. If any subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance or any part thereof is for any reason held to be unconstitutional or otherwise unenforceable, such decision shall not affect the validity of the remaining portion of this ordinance or any part thereof. The People of the City of Santee hereby declare that they would have passed each subsection, subdivision, paragraph, sentence, clause, or phrase thereof, irrespective of the fact that any one or more subsection, subdivision, paragraph, sentence, clause, or phrase be declared unconstitutional or otherwise unenforceable.
- C. Amendment or Repeal. This initiative may be amended or repealed only by a simple majority of the voters at a City election.
- <u>D.</u> <u>Enforcement and Defense of Initiative.</u> The Mayor and City Council shall take all steps necessary to enforce this Initiative and to defend it against any challenge to its validity.
