Hyphenated words that appear in any generally available standard reference dictionary, published in the United States at any time within the 10 calendar years immediately preceding the election for which the words are counted, shall be considered as one word. Dates shall be counted as one word. Any number consisting of a digit, or digits shall be considered as one word. Any number which is spelled, such as "one," shall be considered as a separate word or words. "One" shall be counted as one word whereas "one hundred" shall be counted as two words. "100" shall be counted as one word. Telephone numbers shall be counted as one word. Internet web site & email addresses shall be counted as one word. This section shall not apply to counting words for ballot designations under Elections Code Section 13107. | | |
