(10403; <i>Education Code 5322</i>) Tax rate statement (if applicable) is due to the Registrar of Voters Office. (9401)
87	Aug. 8, 2026	Registrar of Voters to post online measure text and Notice of Argument Deadline.
85	Aug. 10, 2026	Registrar of Voters to publish a Notice of Argument Deadline in newspaper of general circulation. (9163, 9316, 9502)
82	Aug. 13, 2026	<u>DUE DATE FOR ARGUMENTS*</u> Arguments in favor of OR against a measure are due at Registrar of Voters Office. (9163, 9316, 9502)
81	Aug. 14, 2026	<u>DUE DATE FOR IMPARTIAL ANALYSES AND FISCAL IMPACT*</u> Impartial analysis and Fiscal impact (if applicable) due at Registrar of Voters Office. (9160, 9313, 9500)
77	Aug. 18, 2026	<u>DUE DATE FOR REBUTTALS*</u> Rebuttal arguments due at Registrar of Voters Office. (9167, 9317, 9504)
67 to 57	Aug. 28, 2026 - Sep. 7, 2026	Ballots typeset, proofed, translated and printed.
29	Oct. 5, 2026	Mailing of official ballot packets underway. In-office voting begins. (3001,3003)
28	Oct. 6, 2026	County's Official Ballot Drop Boxes open around the county. Find a location near you at sdvote.com . (3025.5, 4005)
15	Oct. 19, 2026	Deadline to register to vote in this election. (2102)
14 to 0	Oct. 20, 2026 - Nov. 3, 2026	Conditional Voter Registration Period – Voters who miss the registration deadline may register and vote. See details at sdvote.com (2170)
10 to 0	Oct. 24, 2026 - Nov. 3, 2026	<u>AVOID DELAYS BY VOTING EARLY:</u> <ul style="list-style-type: none"> • Starting October 24, Select Vote Centers open for daily from 8 a.m. to 5 p.m. • Starting October 31, All Vote Centers open daily from 8 a.m. to 5 p.m. • See details at sdvote.com <u>LAST DAY OF VOTING:</u> November 3, All Vote Centers open from 7 a.m. to 8 p.m.

+ 30	Dec. 3, 2026	Certified results available after the official canvass is completed. Major elections (Primary or General of an even year, for example) may require 30 days; stand-alone or smaller elections may require less time. (15372)

*The legal 10-calendar-day public examination period in which a writ of mandate may be sought begins immediately following the filing deadline for submission of those documents. The writ of mandate request shall be filed no later than the end of the 10-calendar-day public examination period.
