The Hassle-Free Voting Experience: A Practical Guide.

Every active registered voter will automatically receive a ballot in the mail nearly a month before Election Day. You choose **when**, **where**, and **how** you vote! Elections are no longer a one-day event and there is no need to wait until Election Day to vote. You can vote in the comfort of your home or visit a vote center near you. **The choice is yours!**

Here are a few strategies to help make the voting process a more convenient experience for all:

LEARN ABOUT THE PRESIDENTIAL PRIMARY

LEARN. California's presidential primary is March 5, 2024, and political parties decide who can vote for their presidential candidates. Voters who are registered with a political party may ONLY vote in their party's presidential primary.

This means the ballot you receive in the mail or at a vote center will list only your party's presidential candidates. If you want to vote for a presidential candidate from another political party, you need to re-register with that party.

In addition to the party-nominated offices (President and County Central Committee), your ballot will have voter nominated offices, and other local offices and measures. Learn more at **sdvote.com**.

VERIFY YOUR VOTER REGISTRATION

VERIFY. Verify your registration status, register or re-register to vote before February 20. You can do so at **sdvote.com**. Check the back of this pamphlet to find your party registration.

LEARN YOUR VOTING OPTIONS

MAIL IT. DROP IT. VISIT.

VOTE BY MAIL

Sign and date your return envelope, seal your ballot inside, and return it through the U.S. Postal Service.

Remember to sign your return envelope! Your signature is required for your mail ballot to count.

BALLOT DROP BOX

Sign and date your return envelope, seal your ballot inside, and return it to any of the Registrar of Voter's official ballot drop boxes.

Pamphlet Instructions

Ballot information for each of the qualified political parties is provided in this sample ballot and voter information pamphlet. A separate sample of each party's official ballot with their candidates for President and County Central Committee is provided. (The order of the parties is based on voter registration; the party with the most registered voters appears first.) The rest of the offices and measures shown in the sample ballot are for all voters. Combining this information significantly reduces cost.

Look in the back cover of this pamphlet to verify your party registration. You will be issued a ballot for that party.

Most offices previously known as "partisan" are now known as "voter-nominated" (or "top two") offices. Voter- nominated offices include U.S. congressional offices and state legislative offices. The "top two" vote-getters in these contests will advance to the November general election. They may both be registered with the same party, or they may be registered with different parties.



VOTE CENTER

You can vote in person at any vote center in San Diego County.

Starting **Saturday, February 24**, select vote centers will be open daily from 8 a.m. to 5 p.m. until **Saturday, March 2**, when all vote centers will be open daily from 8 a.m. to 5 p.m.

All will again be open on the **final day of voting**, **March 5**, when the hours change to 7 a.m. to 8 p.m.

Come prepared. Mark your selections on the sample ballot found in this pamphlet in advance so that when you go inside the voting booth you can quickly mark your selections.

Vote centers offer a full-service voting experience:

- Vote in-person or drop off an already voted mail ballot (sealed inside its return envelope).
- Use a touchscreen ballot marking device to mark your selections and print out your official ballot.
 - All ballot marking devices are fully accessible allowing voters with disabilities to vote independently and privately.
- Carry in the official ballot you receive in the mail, check-in at the vote center, sign the electronic roster, and cast your official ballot free of its return envelope.
- If you made a mistake or lost your mail ballot, you can instead vote in person using a ballot marking device at any vote center.
- Receive voting assistance, including assistance in multiple languages.
- Register to vote or update your registration and vote on the same day.

Dates to Remember!

Starting **Saturday, February 24**, select vote centers and the Registrar of Voters' office will be open daily from 8 a.m. to 5 p.m., until **Saturday, March 2**, when all vote centers will be open daily from 8 a.m. to 5 p.m.

All will again be open on the final day of voting, **Tuesday, March 5**, when the hours change to 7 a.m. to 8 p.m.

Early voting begins at the Registrar of Voters' office starting **Monday, February 5**, 8 a.m. to 5 p.m., Monday through Friday.

Last day to vote! All vote centers, drop boxes, and the Registrar's office open from 7 a.m. to 8 p.m.

Under the California Voter's Choice Act, each eligible voter in San Diego County will receive a ballot in the mail nearly a month before Election Day. Voters may return their ballot by mail, at an official ballot drop box, or at any vote center. They may also choose to vote in-person at any vote center in the county.

No later than seven days before the day of the election, voters may request a vote by mail ballot in Spanish, Filipino, Vietnamese, or Chinese. For select precincts, voters may request a facsimile copy of the ballot in Arabic, Japanese, Korean, Laotian, Persian, or Somali.

No later than seven days before the day of the election, voters may request a remote accessible vote by mail ballot. This allows a voter with a disability to download a ballot onto a personal computer and mark it privately and independently using their own assistive technology.

To request a vote by mail ballot, facsimile ballot, or remote accessible vote by mail ballot, contact the Registrar of Voters at (858) 565-5800, toll free at (800) 696-0136, or at rovmail@sdcounty.ca.gov.

Conforme la Ley de Opciones para el Votante de California, cada votante elegible en el Condado de San Diego recibirá por correo una boleta electoral alrededor de un mes antes del Día de la Elección. Los votantes pueden depositar su boleta electoral por correo en un buzón oficial para boletas electorales o entregarla en cualquier centro de votación. También pueden optar por votar en persona en cualquier centro de votación del condado.

Al menos siete días antes del día de la elección, los votantes pueden solicitar una boleta de voto-porcorreo en español, filipino, vietnamita o chino. En algunos distritos electorales, los votantes pueden solicitar una copia facsímil de la boleta electoral en árabe, japonés, coreano, laosiano, persa o somalí.

Al menos siete días antes del día de la elección, los votantes pueden solicitar una boleta electoral de voto-por-correo de acceso remoto. Esto le permite a un votante con discapacidad descargar una boleta electoral en una computadora personal y marcarla de forma privada e independiente utilizando su propia tecnología de asistencia.

Para solicitar una boleta electoral de voto-por-correo, una copia facsímil de la boleta electoral o una boleta electoral de voto-por-correo de acceso remoto, comuníquese con el Registro Electoral llamando al (858) 565-5800, al número gratuito (800) 696-0136 o en rovmail@sdcounty.ca.gov.

Sa ilalim ng Voter's Choice Act ng California, ang bawat karapat-dapat na botante sa County ng San Diego ay tatanggap ng balota sa koreo ng halos isang buwan bago ang Araw ng Eleksyon. Maaaring ibalik ng mga botante ang kanilang balota sa pamamagitan ng koreo, sa isang opisyal na ballot drop box, o sa anumang vote center. Maaari rin nilang piliing bumoto nang personal sa anumang vote center sa county.

Sa hindi lalampas ng pitong araw bago ang araw ng eleksyon, maaaring humiling ang mga botante ng balota ng pagboto sa pamamagitan ng koreo sa wikang Spanish, Filipino, Vietnamese, o Chinese. Para sa mga piling presinto, maaaring humiling ang mga botante ng facsimile na kopya ng balota sa Arabic, Japanese, Korean, Laotian, Persian, o Somali.

Sa hindi lalampas ng pitong araw bago ang araw ng eleksyon, maaaring humiling ang mga botante ng remote na accessible na balota ng pagboto sa pamamagitan ng koreo. Nagpapahintulot ito sa botanteng may kapansanan na i-download ang balota sa isang personal na computer at markahan ito nang pribado at nakapag-iisa gamit ang sarili niyang pantulong na teknolohiya.

Theo Đạo Luật Quyền Lựa Chọn Của Cử Tri (Voter's Choice Act) California, mỗi cử tri hợp lệ tại Quận San Diego sẽ nhận được một lá phiếu bầu qua đường bưu điện gần một tháng trước Ngày Bầu Cử. Các cử tri có thể gửi lại lá phiếu bầu qua thư, tại thùng thu nhận phiếu bầu chính thức hoặc tại bất kỳ trung tâm bỏ phiếu nào. Họ cũng có thể chọn bỏ phiếu trực tiếp tại bất kỳ trung tâm bỏ phiếu nào.

Không trễ hơn bảy ngày trước ngày bầu cử, các cử tri có thể yêu cầu lá phiếu bầu bằng thư bằng tiếng Tây Ban Nha, Phi Luật Tân, Việt Nam, hay Trung Hoa. Đối với một số khu bầu cử, các cử tri có thể yêu cầu bản sao lá phiếu bằng tiếng Ả Rập, Nhật Bản, Đại Hàn, Lào, Ba Tư hoặc Somali.

Không trễ hơn bảy ngày trước ngày bầu cử, các cử tri có thể yêu cầu được bầu bằng thư truy cập từ xa. Điều này cho phép cử tri bị khuyết tật tải lá phiếu xuống máy tính cá nhân và đánh dấu một cách riêng tư và độc lập bằng cách sử dụng công nghệ hỗ trợ của mình.

Để yêu cầu lá phiếu bầu qua thư, lá phiếu bầu qua fax hoặc lá phiếu bầu bằng thư truy cập từ xa, liên lạc Văn Phòng Bầu Cử theo số (858) 565-5800, số điện thoại miễn phí (800) 696-0136, hoặc tại rovmail@sdcounty.ca.gov.

《加州選民選擇法案》規定·San Diego縣每名符合資格的選民將於選舉日前一個月左右收到郵寄的 選票。選民可以通過郵寄、官方選票投遞箱或者任何投票中心交回其選票。他們也可以選擇到縣內任 何投票中心進行親身投票。

選民可以要求西班牙文、菲律賓文、越南文或中文版郵寄選票,但不得晚於選舉日前**7**天。在特別選定的選區,選民可以要求索取阿拉伯文、日文、韓文、寮文、波斯文或索馬里文選票的傳真副本。

選民可以要求遠端無障礙郵寄選票,但不得晚於選舉日前7天。這允許身障選民將選票下載至個人電腦,並使用自己的輔助科技工具,有隱私並獨立地標記選票。

بموجب قانون اختيار الناخبين في كاليفورنيا، سيحصل كل ناخب مؤهل في مقاطعة سان دييغو على بطاقة اقتراع عبر البريد قبل شهر تقريبًا من يوم الانتخابات. يجوز للناخبين إعادة اقتراعهم عن طريق إرسال الاقتراع بالبريد، أو في موقع صندوق إيداع الاقتراع الرسمي، أو في أي مركز تصويت. ويجوز لهم أيضًا اختيار التصويت حضوريًا في أي مركز تصويت في المقاطعة.

في موعد لا يتجاوز سبعة أيام قبل يوم الانتخابات، يجوز للناخبين طلب التصويت عن طريق الاقتراع بالبريد باللغة الإسبانية أو الفلبينية أو الفيتنامية أو الصينية. بالنسبة لدوائر انتخابية محددة، يجوز أن يطلب الناخبون نسخة طبق الأصل من بطاقة الاقتراع باللغة العربية أو اليابانية أو الكورية أو اللاوسية أو الفارسية أو الصومالية.

في موعد لا يتجاوز سبعة أيام قبل يوم الانتخابات، يجوز أن يطلب الناخبون التصويت عن بعد عن طريق الاقتراع بالبريد. يتيح ذلك للناخب من ذوي الإعاقة تنزيل بطاقة اقتراع على جهاز كمبيوتر شخصي ووضع علامة عليها بشكل خاص ومستقل باستخدام التكنولوجيا المساعدة الخاصة به.

لطلب التصويت عن طريق الاقتراع بالبريد، أو الاقتراع بالفاكس، أو التصويت الذي يمكن الوصول إليه عن بعد عن طريق الاقتراع بالبريد، اتصل بمسجل الناخبين على580-565 (858) ، الرقم المجاني على 0136-696 (800) ، أو على rovmail@sdcounty.ca.gov.

California州投票権法(California Voter's Choice Act)により、San Diego郡の有権者には、選挙日のほぼ1ヶ月前に投票用紙が郵送されます。有権者は、投票用紙を、郵送にて、あるいは公式な投票ボックス、もしくは投票センターのいずれかで票を投じることができます。また、郡内の投票センターで直接投票することもできます。

選挙当日の7日前までに、有権者はスペイン語、フィリピン語、ベトナム語、中国語による郵便投 票を要求することができます。一部の選挙区では、有権者はアラビア語、日本語、韓国語、ラオ ス語、ペルシア語、ソマリア語のファクシミリ投票用紙のコピーを要求することができます。

選挙当日の7日前までに、有権者は、リモートアクセス可能な郵便投票を要求することができま す。これにより、障害のある有権者は、パソコンに投票用紙をダウンロードし、自分自身の支援 技術を用いて、個人的に独自に投票用紙に印をつけることができます。

니아 유권자 선택법(California Voter's Choice Act)에 따라 San Diego 카운티 내 모든 유자격 유권자 는 선거일로부터 거의 1개월 이전에 우편으로 투표지를 받게 됩니다. 유권자는 이 투표지를 우편이 나 공식 투표지 투입함, 또는 가까운 투표 센터에서 반환할 수 있습니다. 또한, 카운티 내 투표 센터를 직접 방문하여 투표하기를 선택할 수도 있습니다.

유권자는 선거일로부터 7일 이전까지 스페인어, 필리핀어, 베트남어 또는 중국어 우편 투표지를 요 청할 수 있습니다. 일부 선캘리포거구의 경우, 유권자는 투표지 팩시밀리 사본을 아랍어, 일본어, 한 국어, 라오어, 페르시아어 또는 소말리어로 요청할 수 있습니다.

유권자는 선거일로부터 7일 이전까지 원격 접근 가능한 우편 투표지를 요청할 수 있습니다. 이는 장 애가 있는 유권자가 투표지를 개인용 컴퓨터에 다운로드하여 본인의 장애인 보조 기기를 이용하여 개인적 및 독립적으로 기표할 수 있도록 해주는 서비스입니다.

طبق قانون انتخاب رایدهنده کالیفرنیا (California Voter's Choice Act)، هر رایدهنده واجد شرایط در کانتی سن دیهگو، یک برگه رای پستی تقریبا یک ماه قبل از روز انتخابات دریافت خواهد کرد. رایدهندگان برگه رایهای خود را از طریق پست، از طریق صندوق تحویل رای رسمی، یا در یک مرکز رایگیری برمیگردانند. همچنین آنها میتوانند حضوری در یک مرکز رایگیری در کانتی رای دهند.

رایدهندگان حداقل هفت روز قبل از انتخابات، میتوانند درخواست برگه رای پستی به زبان اسپانیولی، فیلیپینی، ویتنامی یا چینی کنند. در حوزههای منتخب رایدهندگان میتوانند درخواست یک نسخه فاکسیمیلی برگه رای به زبان عربی، ژاپنی، کرهای، لائوس، فارسی یا سومالیایی کنند.

رایدهندگان حداقل هفت روز قبل از انتخابات، میتوانند درخواست یک برگه رای پستی رایگیری قابل دسترس کنند. این به رایدهندگان دارای معلولیت امکان میدهد یک برگه رای را در کامپیوتر شخصی خود دانلود کرده و آن را به صورت خصوصی و مستقل با استفاده از فناوری کمکی علامت بزنند.

Accessible Voting

The Registrar of Voters is committed to providing voters with disabilities a secure, independent and private voting experience. Every effort has been made to ensure all vote centers meet usable accessibility standards. Vote centers will feature:

- Accessible ballot marking devices
- Curbside voting
- Additional assistance upon request

Voters that are unable to mark a ballot may bring up to two individuals to assist in voting (§ 14282 (b)).

Disability Rights California will operate a statewide Election Day Hotline for voters having difficulty voting because of a disability, please call (800) 735-2929.



Ballot Marking Device

Ballot marking devices will be available at every vote center. Each ballot marking device is equipped with a headset and a handheld controller for audio-based voting and is also available in Chinese, Filipino, Spanish and Vietnamese.

Remote Accessible Vote-By-Mail (RAVBM) System

The RAVBM system allows a voter with a disability to download a ballot on a personal computer and mark it privately and independently using their own assistive technology. After marking the ballot, the voter will print and return their ballot using the printable envelope template included in the RAVBM instructions. Just like any mail ballot, RAVBM ballots must be sealed inside an envelope, signed, and returned by mail, at any vote center, or official ballot drop box.

To request a RAVBM ballot you can complete the postcard with pre-paid postage located on the back of this pamphlet.

Please call the San Diego County Registrar of Voters (858) 565-5800 or Toll Free at (800) 696-0136 if you have questions about accessible voting in San Diego County.

Voters who are deaf, hard of hearing, or speech-disabled may use the California Relay Service (CRS) by dialing 711 to use the telephone system via a text telephone (TTY) or other devices to call the Registrar's Toll-Free Voter Phone Line. CRS supports the following modes of communication: TTY, VCO, 2LVCO, HCO, STS, VASTS, ASCII, or Voice.

All voter centers will have a full deployment of accessible touchscreen ballot marking devices. These devices can bring up every ballot type in one of five languages and produce a readable paper ballot. Because of this device, voters can vote in person at any vote center in the county.



This device does not store, tabulate, or count any votes, and does not store voter information.



After the voter confirms their selections on the device, the voter will print their ballot in the voting booth with the attached printer. The system prints a readable paper ballot showing the voter's selections along with a secure barcode. The barcode does not store voter information, it is used to tabulate results at the Registrar of Voter's office.


Voters can review their ballot, place it in a secrecy sleeve, and give it to the poll worker to place it in the ballot box to be counted at the Registrar's office. Once placed inside the ballot box, your ballot is officially cast!

Your choices do make a difference. Check them carefully.





Ballot Marking Device (BMD) Voting Instructions



WARNING: CORRUPTING THE VOTING PROCESS IS PROHIBITED!

VIOLATIONS SUBJECT TO FINE AND/OR IMPRISONMENT.

WHAT ACTIVITIES ARE PROHIBITED:

- DO NOT commit or attempt to commit election fraud.
- DO NOT provide any sort of compensation or bribery to, in any fashion or by any means induce or attempt to induce, a person to vote or refrain from voting.
- DO NOT illegally vote.
- DO NOT attempt to vote or aid another to vote when not entitled to vote.
- DO NOT engage in electioneering; photograph or record a voter entering or exiting a polling place; or obstruct ingress, egress, or parking.
- DO NOT challenge a person's right to vote or prevent voters from voting; delay the process of voting; or fraudulently advise any person that he or she is not eligible to vote or is not registered to vote.
- DO NOT attempt to ascertain how a voter voted their ballot.
- DO NOT possess or arrange for someone to possess a firearm in the immediate vicinity of a polling place, with some exceptions.
- DO NOT appear or arrange for someone to appear in the uniform of a peace officer, guard, or security personnel in the immediate vicinity of a polling place, with some exceptions.
- DO NOT tamper or interfere with any component of a voting system.
- DO NOT forge, counterfeit, or tamper with the returns of an election.
- DO NOT alter the returns of an election.
- DO NOT tamper with, destroy, or alter any polling list, official ballot, or ballot container.
- DO NOT display any unofficial ballot collection container that may deceive a voter into believing it is an official collection box.
- DO NOT tamper or interfere with copy of the results of votes cast.
- DO NOT coerce or deceive a person who cannot read or an elder into voting for or against a candidate or measure contrary to their intent.
- DO NOT act as an election officer when you are not one.

EMPLOYERS cannot require or ask their employee to bring their vote by mail ballot to work or ask their employee to vote their ballot at work. At the time of payment of salary or wages, employers cannot enclose materials that attempt to influence the political opinions or actions of their employee.

PRECINCT BOARD MEMBERS cannot attempt to determine how a voter voted their ballot or, if that information is discovered, disclose how a voter voted their ballot.

The prohibitions on activity related to corruption of the voting process summarized above are set forth in Chapter 6 of Division 18 of the California Elections Code.

WARNING: ELECTIONEERING PROHIBITED! VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT.

WHERE: Within the immediate vicinity of a person in line to cast their ballot or within 100 feet of the entrance of a polling place, curbside voting or drop box the following activities are prohibited.

WHAT ACTIVITIES ARE PROHIBITED:

- DO NOT ask a person to vote for or against any candidate or ballot measure.
- DO NOT display a candidate's name, image, or logo.
- DO NOT block access to or loiter near any ballot drop boxes.
- DO NOT provide any material or audible information for or against any candidate or ballot measure near any polling place, vote center, or ballot drop box.
- DO NOT circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- DO NOT distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that include a candidate's name, image, logo, and/or support or oppose any candidate or ballot measure.
- DO NOT display information or speak to a voter about the voter's eligibility to vote.

The electioneering prohibitions summarized above are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

- For this election, United States Senate, United States Representative, State Senate, and State Assembly are voter-nominated offices.
- The two candidates with the highest number of votes in the primary election, regardless of party preference, go on to the general election ballot. There may be two candidates with the same party preference on your ballot for some voter-nominated offices.



(This Measure will appear on the ballot in the following form.)

MEASURE A

MEASURE A. CHARTER AMENDMENT AUTHORIZING THE CITY AUDITOR AND AUDIT COMMITTEE TO USE OUTSIDE LEGAL COUNSEL INSTEAD OF THE ELECTED CITY ATTORNEY. Shall Charter section 40 be amended and section 40.2 be added to authorize the City Auditor and Audit Committee to use outside legal counsel instead of the elected City Attorney, subject to certain conditions, when the Audit Committee determines such use is in the public interest? **Supporters:** Councilmember Vivian Moreno; Assemblymember David Alvarez; Andy Hanau; Elaine Howle; Assoc. of Local Government Auditors. **Opponents:** Clifford Weiler.

This measure requires approval of a simple majority (50% plus 1) of those voting on the measure. Full text of this measure follows the arguments.

OFFICIAL TITLE AND BALLOT SUMMARY

BALLOT TITLE

Amendments to the San Diego City Charter section 40 and the addition of a new section 40.2, authorizing the City Auditor and Audit Committee to use outside legal counsel instead of the elected City Attorney.

BALLOT SUMMARY

This measure would amend the San Diego City Charter (Charter) to authorize the City Auditor and the Audit Committee to use outside legal counsel instead of using the elected City Attorney, subject to certain conditions, when the Audit Committee determines the use is in the public's interest.

If approved by a majority vote of those qualified to vote on the measure, the Charter amendments would become effective after they are chaptered by the California Secretary of State.

CITY ATTORNEY IMPARTIAL ANALYSIS

On April 7, 1931, the voters of the City of San Diego (City) added an elected City Attorney position to the San Diego City Charter (Charter). Under Charter section 40, the City Attorney, who is elected by qualified voters citywide, serves as the chief legal adviser of, and attorney for the City and all Departments and offices. City departments must use the elected City Attorney unless the City Attorney has a legal conflict, as defined by the California Rules of Professional Conduct, or lacks the specialized skill or resources necessary to complete the assigned work.

In 2004, City voters amended the Charter to authorize the Ethics Commission to retain its own outside legal counsel, and in 2020, City voters amended the Charter to authorize the Commission on Police Practices to retain its own outside legal counsel. This measure would again amend Charter section 40 and add a new section 40.2 to authorize the City Auditor and the City's Audit Committee to retain and use outside legal counsel to assist those officials with their responsibilities. The City Auditor, who is appointed by the City Council, conducts audits and may investigate any material claim of financial fraud, waste, or impropriety within the City Auditor's purview under Charter section 39.2. The City's Audit Committee, comprised of two members of the San Diego City Council and three members of the public, directs and reviews the City Auditor's work and has oversight responsibility regarding the City's financial and business practices under Charter section 39.1.

For the City Auditor or the City's Audit Committee to use outside legal counsel, the Audit Committee must determine that such use is in the public's interest. It would not be necessary to show that the City Attorney has a

conflict of interest or lacks the specialized skill or resources necessary to complete the assigned work.

The City Council must approve the contract used to retain outside legal counsel and determine funding each fiscal year. Legal counsel may be hired only after complying with applicable laws, including the City's required competitive procurement processes. The City Council may, by ordinance, create additional rules related to the outside legal counsel consistent with the Charter language.

Any attorney-client relationship between outside legal counsel and the City Auditor, the City Auditor's subordinates, and the Audit Committee must be formed in a manner consistent with California law and the Rules of Professional Conduct of the State Bar of California.

This measure was placed on the ballot by the City Council, following a proposal by the City Auditor. If approved by a majority of the qualified voters voting on the measure, the Charter amendment would become effective when the California Secretary of State officially chapters it.

FISCAL IMPACT STATEMENT

CHARTER AMENDMENT REGARDING INDEPENDENT LEGAL COUNSEL FOR THE OFFICE OF THE CITY AUDITOR AND AUDIT COMMITTEE

This measure would allow the Office of the City Auditor and the City's Audit Committee to contract for outside legal counsel, independent from the Office of the City Attorney, for legal support and advice in certain audits, investigations, and related activities. Any contract would be subject to approval from the City Council, and each use of that contract would be on an as-needed basis and subject to approval from the Audit Committee.

Actual costs for independent legal counsel would vary annually, depending on how frequently independent legal counsel is used, the complexity of the issues involved, and the hourly rate charged for services. Based on past experience, the City Auditor considers requesting independent legal counsel once or twice a year, potentially requiring up to 300 hours of legal services depending on the complexity of the issues, to be a reasonable estimate. The City Auditor anticipates requesting approximately \$180,000 each year for independent legal services, which is estimated to provide the City Auditor's Office with up to 300 hours of legal services consistent with the City Auditor's past experience, as well as an additional 100 to 200 hours for the Audit Committee, if required.

Any unused funds budgeted for independent counsel at the end of any given year would not be expended or carried forward to the following fiscal year, but instead revert back to the City's General Fund. For instance, if no independent legal services are used during a year, no funds would be expended.

ARGUMENT IN FAVOR OF MEASURE A

ARGUMENT AGAINST MEASURE A

Your YES vote protects and strengthens the INDEPENDENCE of San Diego's City Auditor!

Currently, the City Attorney advises BOTH the Office of the City Auditor and the City Officials the City Auditor is responsible for auditing and investigating, which includes the Office of the City Attorney itself. This structure can present conflicts under Government Auditing Standards, which the City Charter requires the City Auditor to follow.

Voters created the Office of the City Auditor in 2008 on the heels of financial scandals that brought the City to the edge of bankruptcy and established it as an **INDEPENDENT** office to serve the public interest and hold all City departments, offices, and agencies accountable to the public through objective, accurate, and transparent audits and investigations.

Your YES vote on Measure A will amend the City Charter to permit the City Auditor and the Audit Committee to obtain independent legal counsel in certain circumstances to better protect the public interest.

Federal government auditors, the California State Auditor, and all California county auditors currently have access to independent legal counsel. Voters previously have overwhelmingly granted both the City's Ethics Commission and Commission on Police Practices authority to retain independent legal counsel to carry out their investigative responsibilities. Measure A seeks to grant the City Auditor similar authority, and provides guardrails to ensure that the authority is used effectively.

This measure is **supported by the Association of Local Government Auditors and the Institute of Internal Auditors**—two internationallyrecognized authorities on the auditing profession. Elaine Howle, California State Auditor from 2000-2021, stated that during her tenure:

"having [independent] legal counsel...strengthened the audit function, benefited the agencies and programs we audited, and most importantly, allowed us to fully serve the taxpayers. **San Diego voters deserve the opportunity to secure these same benefits.**"

Why ask to use an outside attorney unless you want a more favorable opinion from the advocate you select instead of the free neutral analysis of the city's elected legal counsel? This proposed charter amendment epitomizes today's unfortunate polarization - "You are for me or against me." "You are my friend, or are my enemy." "It's my way or the highway." "I hired you, can fire you, or can seek another more favorable advocate in the future; now, what is your legal opinion about this issue I want you to analyze? And if this gets on TV, will you agree with me or say I was wrong?" The elected official city attorney is not impacted by those perils.

The auditor, who conducts performance audits (not just money audits), is appointed per the city charter by the audit committee, which is chaired by a politician (a city council member; city charter, section 39.1). The legal advisor for the auditor should continue to answer directly to the electors, not the individual or committee that hires and fires that lawyer.

Predictions of limited use or costs of a private attorney are meaningless political smoke and mirrors. Use of a private attorney when in "the public interest" is a subjective open door and without oversight. As for any cost estimate, how often has a governmental cost estimate reflected reality, especially involving legal fees? The proposal has no meaningful restrictions on the number of times a private attorney would be hired or the total lawyers' fees per case or annually.

Why authorize a blank check when the service is already being provided without extra costs, and by an elected neutral? Vote no.

FULL TEXT OF MEASURE A

ARTICLE V

EXECUTIVE AND ADMINISTRATIVE SERVICE

SECTION 40: City Attorney

A City Attorney shall be elected for a term of four years in the manner prescribed by Section 10 of this Charter. The City Attorney shall hold office for the term prescribed from and after 10 a.m. on the tenth day of December next succeeding the election and until a successor is elected and qualified. If the tenth day of December falls on a weekend or holiday, the term shall begin at 10 a.m. on the next calendar day that is not a weekend or a holiday.

No person shall serve more than two consecutive four-year terms as City Attorney. If for any reason a person serves a partial term as City Attorney in excess of two years, that partial term shall be considered a full term for purposes of this term limit provision.

The City Attorney shall be the chief legal adviser of, and attorney for the City and all Departments and offices thereof in matters relating to their official powers and duties, except in the case of the Ethics Commission and the Commission on Police Practices, which each shall have its own legal counsel independent of the City Attorney, and in the case of the Office of the City Auditor, which may retain and use independent legal counsel for the City Auditor, the City Auditor's subordinates, and the Audit Committee on the conditions set forth in Charter section 40.2. The attorney and his or her deputies shall devote their full time to the duties of the office and shall not engage in private legal practice during the term for which they are employed by the City, except to carry to a conclusion any matters for which they have been retained prior to taking office. The City Attorney must be licensed to practice law in the State of California and must have been so licensed for at least ten years at the time he or she submits nominating petitions.

The City Attorney shall appoint such deputies, assistants, and employees to serve him or her, as may be provided by ordinance of the Council, but all appointments of subordinates other than deputies and assistants shall be subject to the Civil Service provisions of this Charter. The City Attorney may appoint no more than six Assistant City Attorneys and four other assistants, who shall serve at the pleasure of the City Attorney and may be removed by the City Attorney at any time.

No Deputy City Attorney, who has served continuously as a Deputy City Attorney in the Office of the City Attorney for one year or more shall be terminated or suspended without good cause, except that any Deputy City Attorney may be subject to layoff due to lack of work or insufficient appropriation to meet the salary requirements necessary to maintain existing personnel in the Office of the City Attorney.

To ensure that Deputy City Attorneys conduct their legal work with the highest level of integrity, honesty, and professionalism, good cause for purposes of termination or suspension includes, but is not limited to, failure to comply with the California Rules of Professional Conduct.

It shall be the City Attorney's duty, either personally or by such assistants as he or she may designate, to perform all services incident to the legal department; to give advice in writing when so requested, to the Council, its Committees, the Manager, the Commissions, or Directors of any department, but all such advice shall be in writing with the citation of authorities in support of the conclusions expressed in said written opinions; to prosecute or defend, as the case may be, all suits or cases to which the City may be a party; to prosecute for all offenses against the ordinances of the City and for such offenses against the laws of the State as may be required of the City Attorney by law; to prepare in writing all ordinances, resolutions, contracts, bonds, or other instruments in which the City is concerned, and to endorse on each approval of the form or correctness thereof; to preserve in the City Attorney's office a docket of all cases in which the City is interested in any of the courts and keep a record of all proceedings of said cases; to preserve in the City Attorney's office copies of all written opinions he or she has furnished to the Council, Manager, Commission, or any officer. Such docket, copies and papers shall be the property of the City, and the City Attorney shall, on retiring from office, deliver the same, together with all books, accounts, vouchers, and necessary information, to his or her successor in office.

The City Attorney shall have charge and custody of all legal papers, books, and dockets belonging to the City pertaining to his office, and, upon a receipt therefor, may demand and receive from any officer of the City any book, paper, documents, or evidence necessary to be used in any suit, or required for the purpose of the office.

FULL TEXT OF MEASURE A (CONTINUED)

The City Attorney shall apply, upon order of the Council, in the name of the City, to a court of competent jurisdiction for an order or injunction to restrain the misapplication of funds of the City or the abuse of corporate powers, or the execution or performance of any contract made in behalf of the City which may be in contravention of the law or ordinances governing it, or which was procured by fraud or corruption.

The City Attorney shall apply, upon order of the Council, to a court of competent jurisdiction for a writ of mandamus to compel the performance of duties of any officer or commission which fails to perform any duty expressly enjoined by law or ordinance.

The City Attorney shall perform such other duties of a legal nature as the Council may by ordinance require or as are provided by the Constitution and general laws of the State.

The Council shall have authority to employ additional competent technical legal attorneys to investigate or prosecute matters connected with the departments of the City when such assistance or advice is necessary in connection therewith. The Council shall provide sufficient funds in the annual appropriation ordinance for such purposes and shall charge such additional legal service against the appropriation of the respective Departments.

Effective December 10, 2020, the salary paid to the City Attorney will be equal to the salary prescribed by law and as adjusted by law for judges of the Superior Court for the State of California, provided that the salary of the City Attorney may not be decreased during a term of office.

Whenever a vacancy exists in the office of the City Attorney, an Assistant City Attorney, previously designated by the City Attorney to fulfill duties in the event of a vacancy and whose name has been recorded with the City Clerk as the Interim City Attorney in the event of a vacancy, shall fulfill the duties of the City Attorney as the Interim City Attorney until a replacement can be appointed or elected as provided by this Charter. The Interim City Attorney shall have the full authority of the Office.

SECTION 40.1 [NO CHANGE IN TEXT.]

SECTION 40.2: Legal Counsel for the Office of the City Auditor and Audit Committee

The Office of the City Auditor, acting through the City Auditor, may retain and use legal counsel, independent of the City Attorney, for legal support and advice in audits, investigations, and related activities within the authority and duties of the Office of the City Auditor, subject to the limitations set forth in this section.

The Office of the City Auditor must retain independent legal counsel by contract approved by the City Council in a manner consistent with the Charter, including the City's required competitive procurement processes and other applicable laws. The City Council has discretion to determine and appropriate funding for the Office of the City Auditor's independent legal counsel. The City Council is not mandated to provide any minimum level of funding for the independent legal counsel on an annual or regular basis and must determine funding consistent with the City Council's budgetary authority under the Charter. The City Council may, by ordinance, establish additional rules and procedures to implement this section.

Before the Office of the City Auditor may use the independent legal counsel who is under contract, the Audit Committee must determine that the use on an audit, investigation, or related activity is within the "public interest," as that term is defined by generally accepted government auditing standards promulgated by the United States Government Accountability Office or successor agency.

The Audit Committee may use retained independent legal counsel under the conditions set forth in this section for legal support and advice related to the Audit Committee's oversight responsibilities.

Independent legal counsel retained and used under this section will only be responsible for legal support and advice related to those activities within the authority of the Office of the City Auditor, acting through the City Auditor, and the Audit Committee's oversight responsibilities. Any attorney-client relationship between independent legal counsel and the City Auditor, the City Auditor's subordinates, and the Audit Committee must be formed in a manner consistent with California law and the Rules of Professional Conduct of the State Bar of California.


